National Weatherization Month!

October was National Weatherization Month. Weatherization provides a cost-effective permanent solution for reducing the heavy energy burden on low-income Americans. As the cold weather approaches, most families across the country are turning up their thermostats to combat dropping temperatures. For low-income families, however, cranking up the heat is not always an option. According to the U.S. Department of Energy, these families pay 16.3% or more of their annual incomes for energy compared to 3.5% for others. However, Weatherization can help low-income families save an average of 20—30% per year. The Weatherization Program is available to help make low-income households more energy efficient.

The Weatherization Assistance Program in Delaware County is administered by the Community Action Agency of Delaware County, Inc. (CAADC). The program provides quality energy education and home conservation modifications. CAADC also provides Weatherization services in Lebanon, Chester, Montgomery and Lancaster Counties. All services are free of charge.

Funding for this program is provided by the PA Department of Community and Economic Development. Income guidelines do apply. To apply for the Weatherization Program or for additional information, residents can contact CAADC at (610) 521-8770.

CAADC Making Homes Safer with Lead Paint Hazard Control Program

Community Action Agency of Delaware County, Inc. (CAADC) is now accepting applications for the Lead-Based Paint Hazard Control Program. In this program, qualifying families who have a child age 5 or under may qualify for new windows and other repairs to help remediate lead paint hazards.

Income eligibility guidelines do apply.

Household Size	Maximum Income	<u>(Annual)</u>

One Person	\$52,950
Two Persons	\$60,500
Three Person	\$68,050
Four Persons	\$75,600
Five Persons	\$81,650
Six Persons	\$87,700



Services can include a lead audit, replacing doors and windows, installing new drywall, replacing trim and moldings, educational resources and a final report. All of the services are free if the family is determined eligible.

planning to do in-person and drop-off tax preparation to help keep the community and staff safe. CAADC will also utilize PPE equipment at all of its sites as well.
